1- U.P. State Legal Services Authority (UPSLSA) invites application from eligible legal practitioners for empanelment of 08 Panel Lawyers in the Front Office of UPSLSA for the period of 03 years, under Rule-8 of the National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010 (hereinafter mentioned as to Regulation, 2010).

### **TERMS & CONDITIONS:**

2- The terms and conditions of services of the Panel Lawyers shall be governed as per the National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010, Enactments/Rules/Regulations of the Ministry of Law and Justice, Government of India, NALSA and other relevant rules applicable to the Panel Lawyers for the time being in force. The Terms and Conditions shall also include as follows:-

- (1) The applicant must be a Legal Practitioner, enrolled in the Bar Council of State/ Union Territory.
- (2) No legal practitioner having less than 03 years' experience at the Bar shall be empanelled.
- (3) Legal practitioner against whom disciplinary action taken or complaint pending by/before Bar Council or punishment/conviction awarded in criminal case/contempt proceeding shall not be empanelled.
- (4) The empanelment of a candidate shall be on merit based on interview, his/her experience, character, general conduct and reputation.
- (5) Interview date will be Communicated /informed individually on the whatsapp/e-mail as provided by the candidate.
- (6) The Panel Lawyer, before empanelment, shall have to furnish an undertaking that he/she does not and will not have such financial or other interest as is likely to affect prejudicially his functions as such Panel Lawyer.

- (7) The Panel Lawyers shall be entitled to receive a fixed honorarium of Rs. 2,000 per sitting on rotational basis. The duty chart of sittings of the Panel Lawyers shall be prepared under the directions of Member Secretary, UPSLSA.
- (8) The Panel Lawyer shall not ask or receive any fee /remuneration or any valuable consideration in any manner, from the person, to whom he/ she has rendered legal services under above Regulation, 2010.
- (9) If, the Panel Lawyer engaged is not performing satisfactorily or has acted contrary of the object and spirit of the Legal Services Authorities Act, 1987 and Regulations, 2010, the UPSLSA shall take appropriate steps including his/her removal from the Panel.
- (10) Eligible applicants shall submit their application in the prescribed format available on the website of UPSLSA after downloading the same. Application so downloaded may be filled and signed with applicants photo pasted at appropriate place. The applicant shall also attach his/her self attested documents regarding educational qualification and the certificate issued by the Bar Council.
- (11) Signature is mandatory on the application, as well as, after the verification.
